The appointment of the candidates is subject to production and verification of following certificates (in original) before they are allowed to join by the Development Commissioner Power:-

1. Academic /Technical qualification certificate
2. Matriculation certificate
3. Permanent Resident certificate
4. Reserved category certificate, if any
5. Age and Health certificate
6. Certificate from the concerned authorities to the effect that:-
i/ no loan under employment scheme has been taken by the applicant

- ii/ the stipend, if any, received has been refunded in full into the Treasury
iii/ any other certificate required under rules

No salary shall be allowed to the appointees till verification of their character and antecedents as prescribed under rules is received from the CID.

The appointees shall report to Development Commissioner Power, J&K Jammu within 30 days from the date of issuance of this order failing which their appointment shall be deemed to have been cancelled without any further notice.

The inter-se-seniority of these appointees shall be fixed in accordance with relevant rules separately.
