 - (ii) the stipend, if any, received has been refunded in full into the Treasury.
 - (iii) any other certificate required under rules.

No salary shall be allowed to the appointees till verification of their character and antecedents as prescribed under rules is received from the CID.

The appointee shall report to Development Commissioner(Power) J&K Jammu within 21 days from the date of issuance of this order failing which their appointment shall be deemed to have been cancelled without any further notice.

The inter-se-seniority of these appointees shall be fixed in accordance with relevant rules separately.
