- ii) The placement shall not create any right, interest or equity in favour of the officers as and when considered for promotion on substantive basis through DPC/PSC; and
- iii) The superior claim, if any, shall be considered by demoting the junior most without giving any notice.
- iv) The inter-se-seniority of the officers shall be determined on the recommendations of the concerned recommending agency viz. PSC/DPC; and



- v) The adverse report, if any, received from any quarter, against any officer(s), the placement of the officer (s) as I/C Assistant Engineer shall be cancelled/withdrawn ab-initio without giving any notice.

All the above officers shall continue to work at their present places of postings, till further orders.
