- iv) The inter-se-seniority of the officials shall be determined on the recommendations of the concerned recommending agency viz. JKPSD/DPC and Establishment-cum-Selection Committee.
- v) The adverse report, if any, is received from any quarter, the placement of the officer (s) as I/C Chief Engineer shall be cancelled/withdrawn ab-initio without giving any notice.
