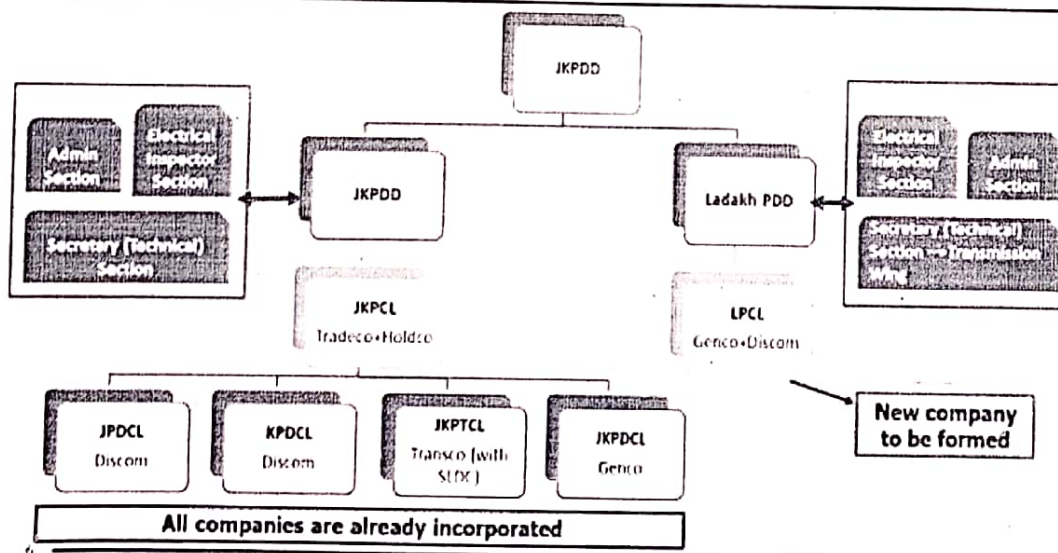
Subject:- Restructuring and unbundling of Jammu & Kashmir Power Development Department (JKPDD), Jammu and Kashmir State Power Development Corporation Limited (JKSPDCL) and J&K State Power Trading Company Limited (JKSPTCL).

Reference: State Administrative Council Decision No.258/22/2019, dated 22-10-2019.

Sanction is hereby accorded to the: -

- (i) Unbundling of the J&K Power Development Department (JKPDD), J&K State Power Development Corporation limited (JKSPDCL) and J&K State Power Trading Company Limited (JKSPTCL) (To be renamed as J&K Power Corporation Limited) as per the following reorganization model: -



- (ii) To transfer all the shares, held by Hon'ble Governor, Jammu and Kashmir in Jammu and Kashmir State Power Development Corporation Limited, Jammu and Kashmir State Power Trading Company Limited (renamed as Jammu and Kashmir

Power Corporation Limited) and Jammu and Kashmir State Power Transmission Company Limited (renamed as Jammu and

Kashmir Power Transmission Corporation Limited) to the Administrative Secretary to the Govt., Power Development Department. The stamp duty payable, if any, shall be exempted.

- (iii) Jammu and Kashmir State Power Trading Company Limited (renamed as Jammu and Kashmir Power Corporation Limited) shall control the composition of the Board of Directors of the following Companies:

- (a) Jammu and Kashmir State Power Development Corporation Limited (renamed as Jammu and Kashmir Power Development Corporation Limited).
- (b) Jammu and Kashmir State Power Transmission Company Limited. (renamed as Jammu and Kashmir Power Transmission Corporation Limited)
- (c) Jammu Power Distribution Company Limited (renamed as Jammu Power Distribution Corporation Limited)
- (d) Kashmir Power Distribution Company Limited (renamed as Kashmir Power Distribution Corporation Limited).

Suitable provisions shall be made in the Articles of Association (AoA) of above mentioned four Corporations and MoA of J&K State Power Trading Company Limited. (renamed as J&K Power Corporation Limited) in this regard.

- (iv) Change in the name of Jammu & Kashmir State Power Trading Company Limited to Jammu & Kashmir Power Corporation Limited. Accordingly, all necessary changes shall be made in the MOA and AOA with regard to functions, name and jurisdiction (UT of J&K only).
- (v) Change in the name of Jammu Power Distribution Company Limited to Jammu Power Distribution Corporation Limited. Accordingly, all necessary changes shall be made in the MOA and AOA with regard to functions and name of the Corporation.
- (vi) Change in the name of Kashmir Power Distribution Company Limited to Kashmir Power Distribution Corporation Limited. Accordingly, all necessary changes shall be made in the MOA and AOA with regard to functions, name and jurisdiction of the Corporation. The jurisdiction of the Ladakh shall be deleted from the mandate of the Corporation.
- (vii) Change in the name of Jammu and Kashmir Power Transmission Company Limited to Jammu and Kashmir Power Transmission Corporation Limited. Accordingly, all necessary changes shall be made in the MOA and AOA with regard to functions,

name and jurisdiction of the Corporation. The jurisdiction of the Ladakh shall be deleted from the mandate of the Corporation.


- (viii) Change in the name of Jammu and Kashmir State Power Development Corporation Limited to Jammu and Kashmir Power Development Corporation Limited. Accordingly, all necessary changes shall be made in the MOA and AOA with regard to functions, name, ownership and jurisdiction of the Corporation. The jurisdiction of the Ladakh shall be deleted from the mandate of the Corporation.
- (ix) Authorize Administrative Secretary, Power Development Department to approve necessary changes in the MOA and AOA of these Corporations which shall be placed before the Board of Directors/shareholders of these Corporations for approval.

(xi)(A) Apportionment, Re-organisation and transfer scheme of JKPDD, JKSPDC, as given in the report submitted by the Committee constituted vide Government Order No: 164-PDD of 2019 dated 20-09-2019.

(B) However, in this apportionment and re-organisation report, some new posts and entities i.e Circles, Divisions, sub-divisions etc have been created in addition to the existing strength. The creation of these new posts and entities and determination of their jurisdiction and resultant changes in the existing entities due to this, shall be done after the approval of Board of Directors of the concerned entities.

(C) Framing of recruitment rules as mentioned in Annex-IV, V & VI of committee's report, have been proposed and the same shall come into force after the approval of the Competent authority.

(D) Wherever in this report, framing of new rules, policies, modification/ amendment in the existing rules etc is required, the approval of the competent authority shall be sought before notification. Accordingly, sanction is also granted to the following: -

(a) Authorizing administrative Secretary, Power Development Department for transfer of staff on as is and where is basis and along with posts from EM & RE Wing, Jammu, Project Wing, Jammu & PMM Wing, Jammu Division to Jammu Power Distribution Corporation Limited on deputation basis from JKPDD.

(b) Transfer of staff of Development Commissioner Power office along with the posts of DCP and other staff to Jammu & Kashmir Power Transmission Corporation Limited and wherever felt necessary on deputation basis from JKPDD.

(c) Transfer of staff on as is and where is basis and along with posts from EM & RE Wing, Kashmir, Project Wing, Kashmir & PMM Wing, Kashmir Division to Kashmir Power Distribution Corporation Limited on deputation basis from

JKPDD except the staff posted in these wings in Ladakh province who shall be transferred to Ladakh Power Corporation Limited (to be incorporated).

- (d) Transfer of staff on as is and where is basis and along with posts from System & Operation Wing and Planning and Design Wing to Jammu and Kashmir Power Transmission Corporation Limited on deputation basis from JKPDD except the staff posted in these wings in Ladakh province who shall be transferred to Ladakh Power Development Department (to be incorporated).
- (e) Transfer of Assets and Liabilities of Jammu and Kashmir State Power Development Corporation Limited falling in Ladakh Province to Ladakh Power Corporation Limited on as is and where is basis.
- (f) Transfer of Assets and Liabilities of Jammu and Kashmir State Power Trading Company Limited falling in Ladakh Province to Ladakh Power Development Department on as is and where is basis. The trading activity in UT Ladakh shall be looked after by Secretary Technical, UT Ladakh.
- (g) Transfer of Assets and Liabilities of EM & RE Wing, Jammu, Project Wing, Jammu & PMM Wing, Jammu Division to Jammu Power Distribution Corporation Limited on as is and where is basis.
- (h) Transfer of Assets and Liabilities of EM & RE Wing, Kashmir, Project Wing, Kashmir & PMM Wing, Kashmir Division to Kashmir Power Distribution Corporation Limited on as is and where is basis.
- (i) Transfer of Assets and Liabilities of DCP office to Jammu and Kashmir Power Transmission Corporation Limited on as is and where is basis.
- (j) Transfer of Assets and Liabilities of System & Operation Wing and Planning and Design Wing to Jammu and Kashmir Power Transmission Corporation Limited on as is and where is basis.
- (k) Authorizing Administrative Secretary, Power Development Department to do all such actions and issue such orders as may be required after the approval of competent authority for the implementation of above decisions.
- (l) The Management of all these Corporations shall frame their Recruitment rules and Delegation of Financial Powers and submit to the Administrative Department for approval after the recommendations of their Board of Directors.
- (m) The Interests of serving employees of JKPDD, JKSPDCL and JKSPDCL shall be protected and shall not be varied to their disadvantages in terms of service benefits.
- (n) All the staff of JKPDD and JKSPDCL proposed for transfer to these successor Corporations and Power Development Department, UT Ladakh shall be transferred on existing terms and conditions protecting their lien and their existing emoluments.
- (o) Till these successor Corporations frame and adopts their own rules, the rules and regulations in vogue in Government shall be applicable.

State Administrative Council further directed that the proposal for regular promotion in the Engineering Cadre of the Power Development Department be processed for consideration of the Competent Authority in the Government through Establishment-cum-Selection Committee, without reference to the Jammu and Kashmir Public Service Commission, as a onetime exception.

SAC further directed that the process be completed by 30-11-2019.


