Sub: Unbundling of Power Development Department

Sir,

With esteemed regards, it has been reliably learnt that the department has once again started the process of unbundling of Power Development Department. In this backdrop, we would like to draw your kind attention towards the Minutes of Meeting held under your Chairmanship on 24.09.2018 wherein it was categorically assured that in case Government proposes to go ahead with unbundling of Transmission/Distribution sectors at a future date, all the stakeholders would be taken on board and all the issues will be discussed threadbare before giving any final shape to such proposal.

JKEEGA being the main stakeholder in this regard would like to request you to share the roadmap/report prepared for unbundling of the department so that it will be discussed threadbare and all its pros and cons are discussed on table before giving any final shape. JKEEGA shall be made aware about each and every development in this regard as unbundling is going to affect the future of thousands of engineers, if not implemented properly.

About six months back, the Government has converted the Commercial and Survey wing into TRADECO but its final shape is not yet getting clear. Nothing has been


said about the service conditions of employees deployed therein or about the employees who have been repatriated back to the department which in itself gives a notion that Government is itself not clear about its proper implementation.

Transmission and Distribution sectors being the major sectors of Power Development Department, if unbundled in the same way as TRADECO, may result in complete chaos and will jeopardize the working of Power Development Department as a whole leading to a State wide crisis as it will directly affect the general public.

As such, it is once again requested that the detailed report of unbundling of Power Development Department needs to be shared and JKEEGA shall be taken on board in each and every decision in this regard.
