The Terms of Reference of the Committee shall be as

under:

To recommend promotion of the officers in the Electrical/Civil/Mechanical wings of the Power Development Department at Assistant Engineer, Assistant Executive Engineer, Executive Engineer and Superintending Engineers level as have been placed on incharge basis from time to time up to 31.08.2019 as a one time exception without reference of their cases to the Jammu and Kashmir Public Service Commission.

- (ii) The Committee shall recommended promotion/regularization of the officers at Assistant Engineer, Assistant Executive Engineer, Executive Engineer and Superintending Engineers level in light of the following inputs:
  - a. Eligibility in terms of Jammu and Kashmir Engineering (Gazetted) Service Recruitment Rules, 1978 of the Public Works (R&B) Department as amended from time to time.
  - b. Seniority
  - c. Integrity
  - d. Work and conduct/APRs.
  - e. Vigilance Status.
  - f. Principles enunciated in Government Order No. 743-GAD of 2007 dated 28.06.2007.
- (iii) The Committee shall complete its exercise within a period of two months.
- (iv) The Power Development Department shall, thereafter, place the recommendations before the Establishment-cum-Selection Committee.
